The competitions will be conducted in accordance with the IAAF Competition Rules, the Anti-Doping Rules and the Competition Regulations approved by the organizers on the territory of each State.

Teams Composition & Structure of Participants in Competitions

Teams Composition: 26 athletes, 8 officials.

Teams Structure: 34 total, including 26 athletes and 8 officials.

Each Team may enter 1 athlete in each event of the competition program in favor of the team, except for the relay (1 medley team in relay race).

Determination of Winners

The winners of the competitions shall be determined separately in the events of the competition program, as well as in the team competition.

Scoring in the team competition is carried out according to the regulations of the competition.

Financing Costs & Conditions of Travel & Accommodation Expenses

Each team must pay the cost of international travel expenses to/from Istanbul, visas (in the case of late submission of documents the visa will be charged for), medical insurance.

The organizers of the competitions pay for local transportation expenses to/from airport/train station to/from the hotel - stadium to the place for competitions/training, sports facilities, etc.

The organizers will provide full board accommodation for the participating teams in the period from 06.03.2020 to 08.03.2020(2 Nights for 34 People)

Arrival and departure should be in accordance with the competition regulations.

Procedure and Deadlines for the Submission of Applications for Participation in Competitions

Applications for participation in competitions must be submitted in accordance with the regulations concerning the carrying out of competitions.

Preliminary Entries with indication of the number of participants and details of the arrival must be submitted via e-mail: ugur.kucuk@taf.org.tr up to January 20, 2020.

Final Entries with indication of the number of participants in events must be submitted via e-mail: ugur.kucuk@taf.org.tr up to February 22, 2020.

Final Confirmations must be submitted with indication of the first and last names of the athletes, events of the competition program, first and last names of coaches not later than the day of the arrival to the competitions venue and the time-frame established by the organizers of the competition.

This contract shall enter into force on the date of its signing by the authorized representatives.
